(SF14.D1.F1) Financial Reports of the Women's Auxiliary

Item 1: Fay W. Hoot, secretary of literature, wrote up a list of the books used during the years 1931-1932. The report claims that three circle reports were used, one auxiliary program, one home circle literature, fifty year books, twenty-five studies in James, twenty-five prayer calendars, three home missions books, and three foreign mission books.

Item 2: Mrs. R.B. Margaret A. Green, the treasurer, submitted a financial report as the treasurers of the Auxiliary for the year 1932-1933. The balance in the bank at the beginning of the term was \$166.60. Contributions were as follows: \$25.95 coming in from a Halloween party, \$52.73 from Circle II, and \$40.60 from Circle I, \$15.00 from the home circle, and \$18.67 from self-denials. Disbursements for the year came to a total of \$163.59, leaving \$3.01 in the bank account. The main disbursements made were \$91.50 for the denominational benevolences and \$17.10 for literature.

Item 3: Mrs. R.B. Margaret A. Green, the treasurer, submitted a financial report for the year of 1933-1934. Circle I managed to bring in \$34.77, while Circle II brought in \$60.56. Combining the dues collected at the Circle meetings with other incomes, the balance of \$3.01 increased to \$160.21. Disbursements for the year varied, with \$17.48 going to literature, \$17.90 going to buildings funds, and \$13.50 going to the local church. A category for disbursements used \$57.39, bringing the balance to \$9.50 at the end of the year.

Item 4: An unspecified treasurer accounted for the financial balance of the year 1934. The financial statements begins by stating that the account of \$9.50 was increased to \$146.49. The main funds that boosted the account varied, with Circle I bringing in \$30.99, Circle II bringing in \$37.05, and the building fund bringing in \$22.73. The list of disbursements was long and came to a total of \$139.85, leaving a balance of \$6.64. The main sources of disbursements were: the building fund using \$31.00, an Auxiliary purse pageant using \$30.00, and literature for the year using \$14.41.

Item 5: Mrs. A.M. Young, treasurer of the Auxiliary, submitted a financial report for the month of April in 1934. The balance on hand at the beginning of the month was \$9.50. Circle I brought in \$3.17, and Circle II brought in \$8.77. While the account was brought to \$21.94 with the dues collected, a check for \$12.41 was written for the literature used within the Circles, bringing the account back to \$9.88.

Item 6: Mrs. A.M. Young submitted a financial report for the month of May in 1934. The account of \$9.88 was brought to \$21.12 from the dues collected by each circle, as well as a birthday offering of \$5.35. Disbursements were few this month, with \$2.00 going to Mrs. Dillard, \$5.35 for Mrs. Knox Elliott's Birthday offering, and \$1.25 for Mrs. Hoots' trip to Selma.

Item 7: An unidentified treasurer conducted a financial report for the month of July in 1934. The balance of \$11.44 at the beginning of the month nearly doubled with an increase to \$22.44. Circle I collected 50¢ and Circle II collected \$10.50. Disbursements for the month were few, with \$1.00 going to a literature study, \$1.00 for Mrs. Cocke (Negro delegate), and two 2¢ taxes on the checks for each, which brought the balance to \$20.40.

Item 8: The treasurer, Mrs. A.M. Young, conducted a financial report for the month of August in 1934. The balance of \$20.40 was brought to \$29.65 with Circle I bringing in \$4.25 and Circle II bringing in \$5.00. The only disbursement for the month was a check for \$1.52 going to Mrs. Dillard for flowers, bringing the account to \$28.13.

Item 9: An unidentified treasurer reported the financial report on October 8, 1934. Dues collected from Circle I amounted to \$3.25, Circle II collected \$4.75, and the building fund contributed \$5.40, bringing the account to a sum of \$16.32. Disbursements for the month came from 15¢ for flowers, and a check for \$6.02 for Holland's, bringing the month's total to \$10.15.

- Item 10: An unidentified treasurer conducted a financial report for the month of November 12, 1934. The balance on hand of \$10.15 was brought to \$28.96. Circle I collected \$1.25, Circle II collected \$1.75, \$6.61 came from the building fund, \$3.20 was collected from a special home missions, and a \$6.00 was received for a refund to Holland's. Disbursements were few, with a check for Dr. R.E. Fulton's special home missions being made for \$3.22, and the building fund of \$12.01 being deposited. The sum at the end of the month came to \$13.73.
- Item 11: Mrs. A.M. Young conducted a financial report for the month of December in 1934. The balance of \$13.73 was increased to \$34.79. Circle I collected \$1.75, Circle II collected \$1.25, the building fund brought in \$5.00, the Christmas pageant raised \$10.28, and a self-denial offering for foreign missions contributed \$2.75. Disbursements came to a total of \$18.03, with materials for the pageant costing \$1.50, 75¢ going to labor for the pageant, \$8.03 being used for ministerial relief, \$2.75 going to R.E. Fulton's foreign missions special, and \$5.00 being deposited for the building fund. The account came to a sum of \$16.76 at the end of the month.
- Item 12: Mrs. A.M. Young conducted a financial report on March 11, 1935 for the month of February. The account increased from \$16.76 to \$33.45 with Circle I collecting \$8.22, Circle II collected \$1.50, a general fund of \$1.25, and a building fund of \$5.72. Disbursements were few, with \$1.00 being used on books, and \$5.72 being deposited for the building fund, bringing the account to a total of \$26.73.
- Item 13: An unidentified treasurer conducted a financial report for the month of April in 1935. The balance at the beginning of the month was \$6.64. A building fund of \$2.00 was raised, Circle I collected \$2.69, and Circle II collected \$11.41, bringing the account to \$22.74. Disbursements were made with a check of \$5.80, \$2.00 was deposited for the building fund, and a \$1.00 check was made out for the Marshall Florist, bringing the sum of disbursements to \$8.80 and the sum total for the month to \$13.94.
- Item 14: An unidentified treasurer conducted a financial report on May 13, 1935. The account was at \$13.94 at the beginning of the month, but Circle I collected \$1.50, Circle II collected \$3.50, literature dues brought in \$1.00, and a birthday offering collected \$5.73, bringing the account to \$25.66. Disbursements made for the month varied, with 50°C going to flowers, a \$3.00 check going to the Marshall Florist, and \$5.73 being raised for Mrs. Knox Elliott's birthday offering. The sum at the end of the month was \$16.43.
- Item 15: Mrs. A.M. Young conducted a financial report on July 1, 1935. The account at the beginning of the month stood at \$16.43 and was increased to \$57.33. A sum of \$26.50 was raised from an alumni picnic to help pay for the building fund, while Circle I collected \$3.50, Circle II collected \$5.90, and the Home Circle collected \$5.00. The only disbursement for the month was the building fund which amounted to \$26.50, leaving the account at a sum of \$30.83.
- Item 16: Mrs. A.M. Young conducted a financial report on September 9, 1935. The account at the beginning of the month stood at \$30.83 and was increased to \$41.13 through the efforts of the Auxiliary. Dues collected from Circle I amounted to \$5.75, Circle II collected \$3.15, 55¢ was collected for the building fund, and 85¢ was brought in by miscellaneous means. Disbursements for the month varied, with \$6.00 going to the building fund, \$1.20 being used for text books and telegrams, 31¢ being used for postage, bringing the account to a sum amount of \$32.77.
- Item 17: An unidentified treasurer conducted a financial report on October 14, 1935. The account total of \$32.77 was increased to \$46.19 through the efforts of the Auxiliary. Circle I and II managed to collect \$7.00, \$1.37 was raised for literature, and the Blue Blessing Box managed to bring in \$5.05. Disbursements varied with \$1.00 going Mrs. Dillard for flowers, \$20.00 for Dr. R.E. Fulton's benevolences, \$20.00 for the building fund, and \$4.80 going to Mrs. Knox Elliot. This leaves the account at 39¢ at the end of the month.

- Item 18: An unidentified treasurer conducted a financial report on December 9, 1935. With the account being left at 39¢ at the end of October, the Auxiliary stressed to collect as much money as possible to make up for the deficit. Dues collected from Circle I amounted to \$2.00, while Circle II collected \$4.00. The funeral home gifted \$3.00, a cash refund of \$2.10 was received for a cash refund on books, \$2.52 was collected through self-denials, \$31.70 was collected from a turkey dinner, and \$6.66 was raised for the building fund. All of these contributions amounted to \$51.98, bringing the account to \$52.37. Disbursements were few but expensive with \$36.40 being used for the building fund, \$3.00 being used at Mrs. Dillard's nursery, \$2.52 going to Dr. R.E. Fulton's foreign missions, \$2.10 being used for mission study books, and \$2.75 going to "Studies in the Holy Spirit." The disbursements came to a total of \$46.77, leaving the account at a sum of \$5.60.
- Item 19: Mrs. A.M. Young conducted a financial report on February 11, 1936. Dues were collected at the beginning of the month from the circle, and money was brought in through a Christmas pageant, self-denials, and by raising money for the building fund. Dues collected amounted to \$18.76, bringing the account balance to \$24.36. Disbursements varied with expenses going to the Christmas pageant, 9 prayer calendars, 2 faith books, a check for R.E. Fulton ministerial relief, and the building fund. Disbursements came to a total of \$14.82, bringing the account to \$9.54.
- Item 20: A financial report filed by an unidentified treasurer was submitted for the month of February without a date of submission. The balance on hand of \$9.95 at the beginning of the month was brought to \$19.49 from the dues collected from Circle I & II, as well as a building fund.
- Item 21: A financial report of all the flowers sent during the year 1935-1936 was written up by an unknown author without a date submitted on it. The dollar amount came to a total of \$12.00 with seven \$1.00 pot plants being sent out, two \$2.00 funeral potted plants, and two 50¢ telegrams being sent out.
- Item 22: A financial report for the year 1937-1938 was submitted by an unidentified treasurer on an unspecified date. The report was as follows: Circle I collected a total of \$57.98 for the year, while Circle II collected \$57.95, the home circle brought in 25¢, \$6.90 from the President, and \$74.80 from the Presbyterian dinners, coming to a total of \$197.88. A category labeled "specials" collected \$32.20 from Blue Blessing Box, self-denials for home and foreign missions, a collection for Montreal delegate, another collection for an improvement fund, and ministerial relief.
- Item 23: A financial report for the year 1942-1943 was submitted by Mrs. R.B. Margaret Green. The report states that \$369.57 was collected through the Circles' dues, birthday offerings, Blue Blessings Boxes, self-denials, cash left over from dinners, cash pew funds, and cash surveys. Disbursements for the year came to a sum total of \$328.49, leaving the balance at \$41.08. The main contributors to disbursements were benevolences, checks for self-denial home and foreign missions, as well as checks to Dr. Robinson for shoes.

- Item 1: Chairman of Circle III, Mrs. Dial, submitted a circle report on June 5, 1919. There were eleven members present of the sixteen enrolled. Budget pledges collected came to a total of \$5.50.
- Item 2: Chairman of Circle III, Mrs. Dial, submitted a circle report on May 7, 1921. There were fourteen members present of the sixteen enrolled, without any new members being added on. Budget pledges collected came to a total of \$4.50.
- Item 3: Chairman of Circle I, Mrs. McLemore, submitted a circle report for the meeting held on August 3, 1924. Of the fourteen enrolled, twenty-eight were present, meaning there were fourteen new members. Budget pledges collected came to a total of \$4.50.

- Item 4: Chairman of Circle II, Mrs. Robb Green, submitted a circle report on May 19, 1930. There were six members present of the fifteen enrolled. The subject of the program discussed at the circle meeting was, "Christian Education & Ministerial Relief." Budget pledges collected came to a total of \$11.25.
- Item 5: Chairman of Circle I, although unidentified, submitted a Circle report for the year 1931-1932. The average of fifteen members attended the meeting. The total budget pledges collected amounted to \$51.65 for the year. A comment written on the report stated that, "I feel that there has been a Spiritual uplift in our circle this year. Don't think we have had as much interest in literature and church papers as we should have."
- Item 6: Chairman of Circle II, Mrs. McDonald, submitted a Circle report for the year ending in March 1932. Total visits made by the members of the Circle amounted to 379, and the sum amount collected by budget pledges was \$48.85.
- Item 7: Chairman of Circle I, Mrs. Young, submitted a Circle report on May 15, 1933. Of the twenty-four members enrolled only seven were present, meaning seventeen were absent. The subject of the program discussed at the meeting was, "Bible Study and Joint Meeting." Budget pledges collected amounted to \$1.32.
- Item 8: Chairmen of Circle I, Mrs. Herbert Young, submitted a Circle report on April 17, 1933. Twelve of the twenty-two members enrolled attended, meaning there were ten absent. The subject of the program discussed at the meeting was, "Bible Study." Budget pledges collected amounted to \$4.20.
- Item 9: Chairman of Circle I, Mrs. Young, submitted a report on August 7, 1933. Thirteen members were present of the twenty-two enrolled, leaving nine that were absent. Budget pledges collected amounted to \$2.25.
- Item 10: Chairman of Circle I, Mrs. Herbert Young, submitted a circle report on August 21, 1933. Fifteen members were present of the twenty-one enrolled, leaving six members absent. There was no money collected from budget pledges this month.
- Item 11: An executive meeting was called by order of the President of the Circles, Mrs. Young, on November 12, 1934. The devotional was given by Mrs. Hoot, the prayer by Mrs. Green, and the officers gave their reports. A pageant was discussed and planned.
- Item 12: Chairman of Circle II, Mrs. McDonald, submitted a circle report on October 14, 1935. Budget pledges collected came to a total of \$29.95.
- Item 13: Chairman of Circle I, Mrs. Young, submitted a circle report on May 17, 1937. Fourteen members were present of the twenty-three enrolled, leaving nine who were absent. The program discussed at the circle meeting was, "The call of Women and Girls of Brazil." Budget pledges collected came to a total of \$5.38.
- Item 14: Chairman of Circle II, Mrs. McDonald, submitted a circle report for July of 1935. Attendance was not recorded, but budget pledges collected amounted to \$1.75.
- Item 15: Chairman of Circle I, Mrs. H.B. Young, submitted a circle report for April of 1937. Attendance was not recorded. Budget pledges collected amounted to \$14.60.
- Item 16: Chairman of Circle I, Mrs. Young, submitted a circle report for May of 1937. Attendance was not recorded. Budget pledges collected for amounted to \$5.38.

The letter states that Revered James McDowell Richards was elected President of the Seminary and Professor of Pastoral Theology. To support his campaign, Mrs. C. Virgina Harrison wrote up the letter to ask that the Auxiliary support the new President with a gift of \$10.00.

Auxiliary Contingent Fund and Benevolences distributed a total of \$75.00, with \$24.00 going to Auxiliary Special Benevolences-Young People, and \$29.00 going to Auxiliary Expenses. Assembly Causes were distributed \$100, with \$27.50 going to Foreign Missions, \$25.00 going to Presbyterial Home Missions, \$13.50 being used for the As. Home Missions, and \$10.00 going to the Orphan Home. The total for both categories came to a total of \$175.00.

Item 2: (Mrs. R.B.) Margaret A. Green, Chairman of the Financial Committee, submitted a report during the month of April in the year 1933. The report, being split into two categories, states that the total amount of money distributed during the month came to a total of \$175.00. The first category, Auxiliary Contingent Fund & Benevolences, was distributed \$85.00, with \$25.00 going to Local Church Work, \$20.00 going to the Building Fund, \$15.00 going to Printing & Postage, and \$6.00 being given to Delegates being sent to the Presbyterial. The send category is the Assembly's Causes, which was distributed a total of \$90.00. Foreign Missions was distributed \$24.75, Presbyterial Home Missions received \$22.50, and Assembly's Home Mission received \$12.15.

Item 3: Mrs. H.B. Young, Chairman of the Financial Committee, submitted a report during the month of April in the year 1933. The report, being split into two categories, states that the total amount of money distributed during the month came to a total of \$175.00. The first category, Auxiliary Contingent Fund & Benevolences, was distributed \$85.00 with \$25.00 being set aside for the Building Fund, \$20.00 going to Local Church Work, and \$15.00 being used for Auxiliary Literature. The second category, Assembly's Causes, received a total of \$90.00. Foreign Missions received \$24.75, while Assembly's Home Missions was given \$12.15, Presbyterial Home Missions receiving \$22.50, and the Orphan Homes being sent \$9.00.

Item 4: Mrs. Lauren Armstrong Secretary of Synodical & Presbyterial Home Missions submitted a report for the year of 1935. The report states that information was sent from Mrs. Minnie R. Patton, S. & P. Sec. of Tuscaloosa Presbyterial on what Synodical and Presbyterial Home Missions should mean to the church and individual, as well as rules and ways to serve as Secretary. An instructive bulletin of the Stillman Institute was sent, as well as record of the students enrolled from Mr. A.L. Jackson. Different reports were received on Presbyterian Home for Children from E.B. Robinson. Month by month activity was sent from Rev. W.A. Ross. And Jane Barry Ross, the Foreign Missionaries, as to what the people in Mexico were doing. Lastly, Notes were sent from Mrs. S.L.V. Simmons, Director of the Educational Dept., as well as a program for the year.

Item 5: Mrs. W. Graham, Secretary of Foreign Missions, submitted an annual report for the year 1935-1936. The report states that three letters were received from Mrs. Hugh W. Underwood, the Presbyterial Secretary, and two letters from Mrs. L. T. Newland, missionary to Korea. Two Foreign Mission programs were presented, one in May and the other in November, as well as four Auxiliary and four Circle programs. In November the Week of Prayer and Self Denial was observed with an average attendance of

thirteen daily and an offering of \$2.52. In March, Rev. J. Kelly Unger, missionary to Korea, and home on furlough, visited the church and told of the mission work in Korea.

Item 6: An unidentified chairman submitted an annual report for the year 1937-1938. Auxiliary Contingent Funds came to a total of \$80.20, with Foreign Missions receiving \$18.25, Presbytery's Home Missions receiving \$12.70, and \$12.50 going to Home Missions. Special Benevolences were distributed a total of \$20.54, with \$15.00 being allocated to provide clothing for the Presbyterian Home. The category of Current Expenses was made up of an \$18.02 purchase of books, \$20.80 for flowers and fruit, and \$1.00 for planting grass.

Item 7: Mrs. H.B. Young, Chairman of the Nominating Committee, submitted a report on February 14. 1938. The report states that the following candidates would be best fitted to serve. Mrs. Louis Whittlesay was proposed for the position of President, Mrs. Rush for the role of Secretary of Foreign Missions, Mrs. H.B. Young for Secretary of Spiritual Life, Mrs. J.M. Partridge for Secretary of Synodical & Pres. Home Missions, Mrs. Frank Curry for Secretary of Literature, Mrs. Albert McLemore as the Secretary of the Blue Blessing Box, Mrs. Kohen for the Secretary of White Cross, Mrs. Sydney Green for the Secretary of Social Activities, Mrs. Clara Davis for the Treasurer, and Mrs. Charley Bailey as the Historian.

Item 8: Mrs. D.B. Woodard, Chairman of Home and Business Circle, submitted a report for the year 1942. The report states that as of April there were twenty members enrolled, twelve in the Business Circle and eight in the Home Circle. The report also states that five members moved out of the city, and two members married and left afterwards. Thirteen new members were enrolled. The total amount of dues collected through the Church was \$48.01.

Item 9: Mrs. Fay W. Hoot submitted a Financial Report for the year 1943-1944. The category labeled "Receipts" came to a total of \$331.88. The largest transactions made were on receipts for \$58.25 from Cash Circle No. 2, \$56.19 from Cash Circle No.1, \$51.04 from Cash Circle No. 3, \$32.75 from Self Denial Home Missions, \$32.00 from Self Denial Foreign Mission, and \$20.00 from Cash Surveys. The second category listed was Disbursements, which also came to a total of \$331.88. The largest Disbursements made were \$75.00 for Benevolences, \$32.75 for Self Denial Home Missions, \$32.00 for Self Denial Foreign Missions, and \$26.21 for Literature.

Item 10: (Mrs. J.L.) Virginia W. McDonald, Secretary of Blue Blessing Box, submitted a report for the year 1943-1944. The reports states that a program on Blue Blessing Box was presented in the Auxiliary. The Blessing Boxes were opened at the Loyalty Meeting and the offering collected was fourteen dollars (\$14.00).

Item 11: (Mrs. J.L.) Virginia W. McDonald, Secretary of Presbyterian Home, submitted a report for the year 1943-1944. The report states that the Auxiliary sponsored Ruby Mitchell for clothing in 1943 until she left the Home, but was then assigned Erely Dean. Four boxes of clothing and cash for shoes sent to Ruby Mitchell and Erely Dean came to a total of eleven dollars (\$21.00), and five boxes of clothing and Christmas gifts sent to the Home for the Thanksgiving offering came to a total of (\$20.00). Combining these funds with the Auxiliary Benevolences came to a total of forty-seven dollars (\$47.00).

Item 12: Mrs. R.B. Green, Treasurer, submitted a report for October and November of an unmarked year. The report states that the balance on hand as of October 9 was thirty-five dollars (\$35.00), Circle I dues came to total of two dollars (\$2.00), Circle II dues came to a total of six dollars and sixty cents (\$6.60), the General Fund contributed one dollar (\$1.00), a Box Sale contributed eleven dollars and five cents (\$11.05), and the Self Denial Offering for Foreign Missions came to a total of five dollars and seventy cents (\$5.70). These contributions brought the balance to sixty-two dollars and twenty-six cents (\$62.26). Disbursements for the month came to a total of fifty-eight dollars and seventy-five cents (\$58.75), bringing the balance to three dollars and fifty-one cents.

Item 13: An unidentified Chairman of the Finance Committee submitted a report for an unmarked date. The report states that the Auxiliary Contingent Fee & Benevolences came to a total of sixty dollars (\$60.00) with Postage using sixteen dollars (\$16.00), the Flower Fund used ten dollars (\$10.00), and the Church Note received fifteen dollars (\$15.00). The Assembly's, Synods, Presbytery's Benevolences and Assembly Causes used a total of sixty dollars (\$60.00), with fifteen dollars (\$15.00) going to the Columbia Seminary, fifteen dollars and seventy-five cents (\$15.75) going to the Foreign Missions, and eight dollars and twenty-five cents (\$8.25) going to the Assembly's Home Missions.

(SF14.D1.F7) Undated Reports for the President of the Auxiliary

Item 1: Mrs. J.L. McDonald submitted a report to the President of the Auxiliary on an unspecified date. The report states that there were twenty-two members at the first of the year, with three newly enrolled members, while losing three, closing the year with twenty-two members. Forty-one dollars and fifty-five cents (\$41.50) was collected for the year. Two dollars and eighty-five cents (\$2.80) was paid for in the order of Literature for the Circles, and four dollars and twenty cents (\$4.20) for the Building Fund. A note was made saying, "I feel we have had a Spiritual uplift in our Circle."

Item 2: Mrs. Margaret A Green, Secretary of the Blue Blessing Box, submitted an annual report for an unmarked year. The amount offered at the end of the year was four dollars and eighty cents (\$4.80).

Item 3: An unidentified Chairman submitted a report for one of the Circles for an unspecified date. The report states that One hundred-nineteen dollars and eleven cents (\$119.11) was paid out and one hundred-twenty dollars and thirty-one cents was brought forward, bringing the balance to one dollar and twenty cents.

Item 4: An unidentified Secretary submitted a report of the amount of pledges collected during and unspecified year. Circle I pledged sixty dollars and eighty cents (\$60.80), Circle II pledged fifty-nine dollars and forty cents (\$59.40), the Home Circle raised three dollars (\$3.00), and the President contributed six dollars (\$6.00).

Item 5: An unidentified Secretary of Christian Education & Ministerial Relief submitted an annual report for an unmarked year. The report states that a program was presented last April at the Auxiliary meeting. A Christmas pageant was put on that raised an amount of twenty-two dollars (\$22.00).

Item 6: Mrs. Fay W. Hoot, Secretary of Foreign Missions, submitted a report of all programs given in an unspecified year. The report states that two Auxiliary programs were given and one circle program was given. There was a sponsored Sunday school program in May that was put on by the Pioneer group. There was an Observed Foreign Mission Study Period, and week of prayer and self-denial. Two books were presented; "For all of Life", and "A Silent Billion Speak." Dr. Richardon, a retired missionary from China, spoke one night. A total of fifty-seven attended the Mission Study Class. The offering came to a total of thirty-two dollars (\$32.00).

Item 7: Mrs. Margaret Green, Secretary of Synod's and Presbytery's Home Missions, submitted a report to the President of the Auxiliary during an unmarked year. The report states that the packet of literature for the S. & P. Secretary was received. The women of the Auxiliary gave a little over twenty-five dollars (\$25.00) to the Defense Service Council offering in April. The June program, "An All-Out Defense on the Home Front" was presented at the Auxiliary Inspirational Meeting. Efforts were made to present facts of interest to the Auxiliary as learned from the Supt. of Home Missions in Tuscaloosa Presbytery and facts gleaned from Minutes of Presbytery and Synod. The report also states that ten dollars (\$10.00) was given last year, the year of the report, and another ten dollars was to be raised the next.

- Item 8: Mrs. Lula C. Dial, Secretary of Presbyterian Home for Children, submitted an annual report for an unmarked year. The report states that a quilt was sent in July and box of clothing to the Home. In October, clothing was sent for the winter to Lila Ruth Austin. On November 26, a dress and a comb was sent for her birthday. Nine hundred sixty-five soap wrappers were sent out, as well as one hundred seven jello boxes. Six letters were received from Dr. Robinson and one card from the Presbytery Secretary, Mrs. Hester of Eutaw.
- Item 10: Mrs. Pearl C. Partridge, Chairman of R. Ed, submitted an annual report during an unmarked year. The report states that a new Junior & Intermediate Youth Pastor was on its way in, and that there were high hopes of the new Secretary being successful in organizing a new program to build the attendance.
- Item 11: Mrs. Fay W. Hoot, Secretary of C. E. & M. R., submitted an annual report during an unmarked year. The report states that the Auxiliary and circle programs were given. The Auxiliary program was distributed at night in the form of a pageant. A Joy Gift Service was given and a collection was taken up that amounted to eight dollars and forty-five cents (\$8.45).
- Item 12: Mrs. C.W. Bailey, Secretary of the Presbyterian Home for Children, submitted a report during an unmarked year. The report states that one box of clothing was sent to the Home, two boxes and six dollars (\$6.00) went to Frances Chappell. The Pioneers sent school supplied to the Home and the Primary Dept., as well as a shower of Valentines to the orphans. Two hundred sixty-six soap coupons were sent.
- Item 13: Mrs. Lula C. Dial, Chairman of the Home Circle, submitted a monthly report for an unmarked year. The report states that the Home Circle has four members. Easter Greetings were sent out, as well as leaflets, daily Bible readings, and blessing boxes. Two members were beginning to compile a scrap-book. Five dollars (\$5.00) was collected from the Circle.
- Item 14: Mrs. Pearl C. Partridge, Secretary of Spiritual Life, submitted an annual report for an unmarked year. The report states that the week of prayer and self-denial for foreign missions took place in October and November. The week of prayer and self-denial for home missions took place in January and February. A note was made that special prayers were emphasized for three months with little result. The goal of reaching fifty-six members at church services was looking bleak, but efforts were being made to change that by visiting the prayer circles to inform the members of service times.
- Item 15: A letter from the nominating committee was submitted on an unspecified date. The letter states that Mrs. H.L. Hoot was nominated to be Vice President and Mrs. J.J. Rigdon was nominated for the position of Secretary.
- Item 16: Mrs. Pearl C. Partridge, Secretary of Spiritual Life, submitted an annual report for an unmarked year. The report states that on August 28 there was a prayer band. Sixteen members were present. A note at the end reads, "Prayer yields fruit so please remember schools and colleges, Y.P., and Home Missions."
- Item 17: Mrs. Pearl C. Partridge submitted a report for each of the circles in the month of April. The report states that there was a prayer band in each circle to help organize and serve in the Executive Board. Prayer calendars were discussed as well.
- Item 18: Mrs. Fay W. Hoot, Vice President of the Auxiliary, submitted a report for an unspecified date. The report states that the report was written in partnership to the Vice President. All meetings presided over in absence of the President of the Executive Board & Auxiliary. The program material and Home Circle literature was delivered to the chairmen and leaders.
- Item 19: An undated report listing the members of the Executive Board was written by an unidentified person. The reports states that Mrs. Grant was the Historian, Mrs. Dial was Secretary of Chr. Ed. & Min. Rel., Mrs. Partridge was Secretary of Spiritual Life, Mrs. McDonald was Secretary of Christian Social

Service, Mrs. Waite was the Secretary of Social Activities, Mrs. Hitt was the Secretary of Home Missions, Mrs. Hatcher was the Pastor's Aid Secretary, Mrs. Cobb was the Secretary of Religious Ed., Mrs. Ross was the Secretary for the Home for Children, Mrs. Hoot was the Vice President, and Mrs. Rigdon was the Secretary.

Item 20: A report written by an unknown secretary was submitted on an unspecified date. The report states that Mrs. Green, Secretary of Foreign Missions, reported that Literature was dispersed to the children. Mrs. McLemore received a letter from Stillman. Mrs. McDonald ordered literature and stressed the importance of Survey Week, especially to the Executive Board. Mrs. Hoot discussed the study books, and appointed the nominating committee to Mrs. Coleman Dial Cobb. A letter was received from Mrs. Johnston reminding the Circle that the year was coming to a close.

Item 21: Mrs. Leila J. Cocke, Secretary of Spiritual Life, submitted a report to the President on an unmarked year. The report states that two cards were received from the Presbyterial Secretary and from our Atlanta office. Leaflets were ordered and distributed, same with pledge cards and Bible Readers. A Week of Prayer was observed for Foreign Missions from November 3-10 and for Home Missions from Janurary 19-26. The study book "Faith of Our Fathers" was read. There were ten prayer calendars in stocks.

Item 22: Mrs. Roberta Whittlesey, Secretary of Religious Education, submitted a report on an unmarked year. A successful Summer Vacation Bible School with the help of the pastor and Auxiliary. In September, the secretary put the Auxiliary program on Religion Education. The Rally Day program in the Sunday School was sponsored by the secretary.

The list of Officers was as follows: Mrs. R.K. Dent was president, Mrs. W.A. McLemore was Vice President, Mrs. W.J. Graham was Secretary, Mrs. H.G. Cobb was Treasurer, Mrs. F.N. Grant was Secretary of Foreign Missions, Mrs. H.B. Young was Secretary of Assembly's Home Mission, Mrs. Jim McDonald was Secretary of S. & P. Home Missions, Mrs. J.M. Partridge was Secretary of Chr. Ed. & Min. Rel., Mrs. J.C. McDonald was Secretary of S.S. & Y.P work, Mrs. A.G. Harm was Secretary of Literature, and Mrs. Oscar Hitt was Secretary of Chr. Social Service. The first Monday of each month was dedicated to Circle Business and an Executive Meeting, the second Monday was used to study the Circle Program and Bible, the third Monday was used to study the Auxiliary Program and to socialize, the fourth Monday was an Auxiliary Business Meeting, and the fifth Monday was used for Joint Bible Studies.
